TERMS AND CONDITIONS OF USE FOR SKI WARD SKI AREA SEASON PASS HOLDERS

- SEASON PASS USAGE:** Your Season Pass is for the ski area (skiing and snowboarding only), it does not include the Tubaslide, and is only valid for scheduled practice and race times. Family passes are for immediate family members only, and any misrepresentation will result in the pass being revoked without compensation. Your pass may not be used by anyone but yourself. Transferring or the attempt to transfer will result in revocation of the pass without refund, and is punishable under MA THEFT OF SERVICES LAW. If in the event a transfer or use by another, or any other act which in management's opinion is misconduct or misuse of the facilities, unsafe actions or failure to follow safety guidelines set forth in the Skier's Responsibility Code, management may revoke your season pass without a refund. Your Season Pass must be presented to any authorized Ski Ward representative upon request
- LOST:** Any loss should be reported to Ski Ward management immediately to prevent misuse. There is a \$15.00 fee for the replacement of lost passes. New passes can only be processed during weekday operating hours.
- FORGOTTEN:** A Full price ticket must be purchased if a Season Pass holder forgets their pass. There will be a one time allowance per person of a \$10.00 lift pass when Season Pass card is forgotten. This will be noted on pass application. After the first time, a ticket **MUST** be purchased. **NO** exceptions.
- REFUNDS:** No refunds will be issued on Season Pass purchases.
- PASS VISIBILITY:** It must be displayed on your outer garment at all times when you are in the lift lines for quick, easy access to ticket checkers. Ski Ward is not responsible for a device to attach pass.

RELEASE FROM LIABILITY

I understand and accept the fact that alpine skiing and snowboarding in their various forms are a hazardous sport that has many dangers and risks. I realize that injuries are a common and ordinary occurrence of this sport. I agree, as a condition of being allowed to use this ski area's facilities and premises, that I freely accept and voluntarily assume all risks of personal injury and/or death and/or property damage, and release Ski Ward, Inc. (D.B.A. Ski Ward Ski Area) and it's agents, employees, directors, officers, and shareholders from any and all liability for personal injury or property damage which results in any way from negligence, conditions on or about the premises and facilities, and the operations of the ski area including, but not limited to, grooming, snowmaking, ski lift operations, actions or omissions of employees or agents of the area, or my participation in skiing or other activities at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result.

I, the undersigned, have read, understand and accept the terms of the above Terms & Conditions and Release Agreement, which is an essential part of it. I am signing it freely and of my own accord, realizing it is binding upon myself, my heirs and assigns, and in the event that I am signing it on behalf of a minor, that I have full legal authority to do so, realizing it's binding affect on them as well as myself. As a condition of holding a Season Pass Identification Card and being permitted to use any and all of the facilities at the ski area (with the exception of Tubaslide), I further agree to assume all risk of personal injury or loss or damage to any of my property.
