TERMS AND CONDITIONS OF USE FOR SEASON PASS HOLDERS

- SEASON PASS USAGE:** Your Season Pass is for the ski area only (skiing and snowboarding). Season Pass does not include TubaSlide or Summer Activities. **Additional \$10.00 Park Pass and liability release required for Terrain Park use.** Family pass discount is for immediate family members only. Any misrepresentation will result in a revocation of the pass without compensation. Passes must be used by passholder only. Passes are non-transferrable. Any attempt to transfer will result in revocation of the pass without refund and is punishable under MA THEFT OF SERVICES LAW. If in the event a transfer, use by another or any other misconduct or misuse of the facilities, unsafe actions or failure to follow safety guidelines set forth in the Skier's Responsibility Code, management may revoke your season pass without refund. Upon request your Season Pass must be presented to any authorized Ski Ward representative.
- FORGOTTEN PASSES:** Each pass holder may receive a ONE TIME complimentary lift ticket when their Season Pass is forgotten. Subsequent instances will require that a ticket be purchased. NO exceptions.
- LOST PASSES:** Any loss should be reported to Ski Ward management immediately to prevent misuse. Any pass replacement will incur a \$50.00 fee. Replacement passes will only be processed during weekday operating hours.
- REFUNDS:** Refunds will not be issued on Season Pass purchases.
- PASS VISIBILITY:** Passes must be displayed on your outer garment at all times when in the lift lines for quick, easy access to ticket checkers. Ski Ward is not responsible for devices, which attach pass.

RELEASE FROM LIABILITY

I sign this release both individually and as parent/Guardian with legal authority and responsibility for any minor children named on this form. I sign it freely realizing it is binding upon myself, my heirs and assigns and any children listed on this form. I consent and agree to the use of the ski area by those minor children. I certify that those children are in good physical condition and that we are aware that this program provides no Health/Accident Insurance. (D.B.A. Ski Ward Ski Area) its officers, officials, agents, representatives, affiliated companies and/or employees, with respect to any and all liability, loss, damage, costs, claims, and/or causes of action, including but not limited to injury, disability, death, or loss or damage to person or property related in any way to the use of the ski area by myself or any children listed on this form, whether arising from the negligence of Ski Ward Inc., its officers, officials, agents, representatives, affiliated companies and/or employees, or conditions on or about the premises and facilities, or the operations of the ski area, including but not limited to ski instruction, grooming, snowmaking, equipment setting, lift operations and maintenance.

I further release and give up any and all claims and rights that I may now have against Ski Ward, Inc. This releases all claims, including those of which I am not aware and those not mentioned in this release. This release applies to claims resulting from anything which has happened up to now. I further agree to indemnify and hold harmless Ski Ward Inc., its officers, officials, agents, representatives, affiliated companies and/or employees from any and all liabilities including the use of the ski area by any minor child named on this form, even if arising from the negligence of Ski Ward Inc., its officers, officials, agents, representatives, affiliated companies and/or employees, to the fullest extent permitted by Law.
