**GENERAL PROGRAM INFORMATION:**

- All programs begin the week of January 2, 2020
- \*If you are renting equipment, you must pre-fit by December 20, 2019
- Multi-week lesson programs will not be held on MLK Day (Jan. 20, 2020) and February vacation week (Feb. 17-21, 2020).
- Badges must be picked up by 1 January 2020 for multi-week programs.
- A \$10 replacement fee will be applied to all lost or forgotten badges.
- Free ski/ride after programs is unsupervised; an instructor will not be present for this time. We advise that you talk to your child to set up a meeting time and place if you allow them to participate in free ski/ride.

**CANCELLATION POLICY:** Cancellations for all Ski Ward programs will be announced via email and posted on our website ([www.skiward.com](http://www.skiward.com)) by 12 noon. Cancellations will be made up at the end of the program. ONLY lessons cancelled by Ski Ward will be rescheduled.
